# PROGRAM HIGHLIGHTS

## Health Services

The Cross-Cultural Health Services Clinic was a busy place in the year 2002. Community members made use of the Family Health, Women's Health, and Chiropractic services offered as well as the regular eye screening for seniors. This past year was year 2 of the 3 year Cervical Cancer Prevention Initiative, a community-based research study designed to examine immigrant women's understanding of health and illness and to investigate whether health education workshops are successful in increasing knowledge about and receiving Pap tests, used to screen for cervical cancer. The job skills training program offered to foreign-trained health professionals was another active component of the clinic, providing orientation and specific training to health care professionals with credentials from another country who hope to pursue Canadian careers in health care.

## Family Resource Program/ Emergency and Occasional Childcare Program

For over 20 years our Family Resource Program has offered a drop-in, weekly Indoor Park, resource library, referrals and parent support. In 2002 we added a number of programs to further promote the healthy and positive development of children aged 0 - 6 in this community: Peer Nutrition, Family-Literacy and School Readiness. All have been very successful, particularly in assisting newcomer families to prepare for their children's educational experience.

The Emergency and Occasional Childcare Program continues to be the only one of its kind in the city by offering flexible, affordable and high quality childcare to parents and caregivers who are not able to access other sorts of childcare. Clients include families in need, parents / caregivers seeking employment, housing or more permanent childcare, parents who require temporary childcare, parents in crisis, caregivers who have appointments and those that simply want a break! The demand for and success of this service is an indicator of its' value and Scadding Court is pleased to be able to continue offering it to the community.
